#### What is an Applicants' Briefing?

An Applicants' Briefing is a meeting conducted by a representative of the State (Maryland Emergency Management Agency) for all potential applicants for public assistance grants. The briefing occurs after a major disaster has been declared and addresses application procedures, administrative requirements, funding, and program eligibility criteria specific to the declaration.

#### Who should attend?

Eligible applicants are encouraged to attend a briefing. Eligible applicants include State Government Agencies, Local Governments, and Private Nonprofit organizations that own or operate facilities that provide certain services of a governmental nature (i.e., educational, emergency, medical, utility, museums, zoos, libraries, community centers).
